The **University of Macerata**, **Department of Law** offers international incoming students the *Transnational Law & Culture programme*, a series of courses in English (up to 67 ECTS overall) in order to help maintain an international approach to the legal sciences, while benefitting the facilities of the highly ranked University of Macerata, and the lifestyle of a beautiful medieval Italian city.

International Law / 12 ECTS Prof. PAOLO PALCHETTI International students are free to choose the courses they are interested in. They may also benefit from a 10-hour seminar of Introduction to Italian Law, held at the beginning of the first semester, whose attendance provides them with 2 additional credits (ECTS). In that seminar, the lecturers involved in the programme supply basic information regarding the main issues forming the subject of their courses, in order to foster the integration of foreign students; alongside that basic information about the UniMC library system and databases will also be provided.

In addition, Italian and foreign visiting professors in Macerata will be involved in the programme alongside **UniMC lecturers** whenever pertinent depending on their topics of interest and research, in order to broaden the overall perspective of the programme. International students enrolled in the **TL&C** programmed are strongly encouraged to attend these additional seminaries and classes.
