**University of Macerata, Italy**

**AGREEMENT OF COOPERATION FOR THE PROVISION OF  
SUMMER SCHOOL PROGRAM FOR  
BEIJING NORMAL UNIVERSITY, CHINA**

between

Beijing Normal University, Beijing, China (hereinafter referred to as BNU)

and

University of Macerata, Italy (hereinafter referred to as UniMc)

**Background**

BNU and UNIMC agree to work collaboratively in the areas of creativity, innovation, Western culture training.

**Terms of Cooperation**

Both parties have agreed as follows:

1. UNIMC will develop and deliver Summer School for BNU students. Participants will arrive in Macerata to coincide with the commencement of UNIMC program dates.
2. The curriculum content and course materials for the Summer Schools will be delivered as per the final proposal.
3. The cost of the program including tuition, activities, airport transfers and accommodation will be negotiated to the satisfaction of both parties.
4. Beijing Normal University will:
  - (i) select and organize BNU students for the programs.
  - (ii) meet all the travel costs for the participants' travelling between Beijing and Macerata.
  - (iii) meet all participants' costs, including tuition, accommodation and cultural activities during their program in Macerata.
  - (iv) meet the cost for the participants' visas and travel insurance.
5. UNIMC will
  - (i) develop, deliver, and evaluate the programs for BNU students.
  - (ii) arrange airport transfers for arrival and departure transfers as


outlined in the proposal.

- (iii) arrange accommodation for the participants for the duration of the programs.
  - (iv) provide access to UNIMC facilities as outlined in the proposal.
  - (v) provide each participant with a "Certificate of Completion" and, for each Summer School, provide BNU with a final Record including Credit transfer, with six weeks of the end of each program.
6. Specific and further initiatives developed under this cooperation agreement will be ruled by subsequent agreements.
  7. The economic and financial issues will be regulated by a specific document where the financial and operation plan of every course is approved. Payment date: BNU will pay UNIMC, on receipt of an invoice, all agreed program costs four weeks prior to course commencement.
  8. This Agreement is non-exclusive and does not prevent either party entering into similar arrangements with other organisations.
  9. This Agreement has the duration of 3 years from signature.
  10. Either party may terminate this Agreement by giving the other party one month's written notice.


### Signatories
