



Memorandum of Understanding

BETWEEN

THE LAW SCHOOL OF THE BEIJING NORMAL UNIVERSITY, CHINA

AND

THE DEPARTMENT OF LAW OF THE UNIVERSITY OF MACERATA, ITALY

Beijing Normal University Law School, Beijing, China, and the University of Macerata Department of Law, Macerata, Italy, desiring to promote the academic and practice exchange and cooperation between the two institutes, are to sign this Memorandum of Understanding, and, based upon the principles of reciprocity and equality through the process of the amicable negotiation, have agreed to the following.

- 1. Both institutes have agreed to promote the following personal and material exchanges and cooperative programmes:
 - Exchanges of students, who should be made eligible to take exams in the host institutes and whose credits should be reciprocally recognized;
 - Exchanges of professors and junior scholars for the purposes of research and teaching;
 - Exchanges of doctorate students;
 - Development and implementation of joint research programmes and seminars in specific fields;

- Joint education of doctorate students and undergraduate students, with mutual recognition of credits.
- Further cooperation is wished provided the necessary preconditions.
- As a general principle, arrangements for specific visits, exchanges, and other forms of cooperation will be developed jointly and will be agreed upon, in writing, for each specific case.
- Any ongoing joint project between the two institutions will require a supplementary written agreement, specifying the terms and nature of the programme.
- No money will be exchanged under this agreement between the institutions who are parties hereto. Both parties understand that all financial arrangements for future projects will have to be negotiated and agreed upon by the parties, in writing, and will depend on the availability of funds for each party.
- 2. In case of amendments and modifications to this memorandum, both institutes will consult with each other about the contents of the memorandum to be added or modified, so that the two parties will amend or modify the contents, or arrange a new agreement.
- 3. Each institute will indicate the individual who will take charge of the contact works in their respective locations for the smooth and cooperative performing of the agreements and for the consultation about the detailed planning of the programme items. Both institutes will do one's best in responding to the proposal of the counterpart institute.

This agreement will be effective for a period of five years commencing from the date of signature. In case of need to be terminated or amended, either institute may terminate this agreement by giving 6 months notice in the form of the officially written letter to the other institute. If there is no notification for the termination of the

relationship, this agreement will be automatically prolonged for a period of 5 years.

This Memorandum of Understanding is made out and signed in English. It will come into force with the signature of the representatives of the two institutions.
